THERE WERE 239 COMMUNITY MEMBERS THAT SERVED AS VOLUNTEER ADVOCATES WITH CASA'S ADVOCACY PROGRAM IN FY18. THESE COMMUNITY VOLUNTEERS DONATED 11,704.78 HOURS OF SERVICE AND 98,636.63 MILES TO ENSURE EFFECTIVE ADVOCACY WAS PROVIDED TO 675 OKLAHOMA COUNTY FOSTER YOUTH. OF THE CHILDREN SERVED IN FY18, 45% WERE AGE 5 AND UNDER WITH 85% UNDER THE AGE OF 12.

CASA VOLUNTEERS ENSURED THAT 216 FOSTER CHILDREN FOUND SAFE PERMANENT HOMES IN FY18, A 39% INCREASE IN SUCCESSFUL OUTCOMES FOR FOSTER YOUTH FROM THE PRIOR YEAR. CASA OF OKLAHOMA COUNTY ALSO UNDERWENT AN AGGRESSIVE STRATEGIC
